In response to the Proposed Order of the Administrative Law Judge in regard to item # 11 stating:

the Commission has the authority under Section 8-503 of the Act to require the removal of the abandoned pipeline and should direct IGTC to do so when the analysis described in the prefatory portion of this Order indicates that removal is warranted;

It is our request that the Commission require IGTC to remove any portion of the abandon pipe from property of landowners who request it to be removed especially from tillable land where there may be a hazard in the future. We are reluctant to trust IGTC's rhetoric in its statements of a case by case study as to if the pipe will be removed. Should landowners have a problem with IGTC in their request to remove the pipe, some form of recourse needs to be attached to this ruling.

WHEREFORE, for all reasons stated herein, we as landowners respectfully requests that ICC consider our request to include the above request.
