PETITION

Comcast Business Communications, LLC ("CBC") hereby files this petition to discontinue the provision of all services listed in its Illinois Tariff Number 1 (collectively, "Discontinued Services"), which it requests permission to withdraw. CBC plans to discontinue the Discontinued Services throughout Illinois on July 1, 2009. CBC also requests that the Commission cancel CBC's certificate to provide long distance services, which it was granted on April 26, 2006 under Case Number 06-0342. *Other Comcast entities are not affected by this discontinuance, as CBC is the only Comcast entity discontinuing any service.*

There are five customers affected by the discontinuance. CBC has sent notice of the discontinuance to the affected customers. Attached hereto as Exhibit 1 is a copy of the notice of the discontinuance sent to all affected customers.

CBC requests a waiver of the Commission's hearing requirement.

WHEREFORE, Comcast Business Communications, LLC respectfully requests that the Commission authorize the discontinuance of CBC's intrastate interexchange telecommunications services offerings in Illinois.

FCC Notice

The discontinuance of your long distance service is subject to regulatory approval by the Federal Communication Commission ("FCC"). The FCC will normally authorize this proposed discontinuance of service unless it is shown that customers would be unable to receive service or a reasonable substitute from another carrier or that the public convenience and necessity is otherwise adversely affected. If you wish to object, you should file your comments as soon as possible, but no later than 15 days after the Commission releases public notice of the proposed discontinuance. Address them to the Federal Communications Commission, Wireline Competition Bureau, Competition Policy Division, Washington, DC 20554, and include in your comments a reference to the § 63.71 Application of Comcast Business Communications, LLC. Comments should include specific information about the impact of this proposed discontinuance upon you or your company, including any inability to acquire reasonable substitute service.


