QUARTERLY REPORT

(July 1, 2009 – September 30, 2009)

To the ILLINOIS COMMERCE COMMISSION:

Northern Illinois Gas Company d/b/a Nicor Gas ("Nicor Gas" or the "Company") hereby submits its quarterly report for the period July 1, 2009 through September 30, 2009, pursuant to 83 Ill. Adm. Code 240 and the final order of the Commission entered July 08, 2009 in the above-entitled cause. For the report period, Nicor Gas states as follows:

1. On July 30, 2009, Nicor Gas issued \$50,000,000 as First Mortgage Bonds, 4.70% Series due July 30, 2019. The bonds were sold, under a Supplemental Indenture with The BNY Mellon Trust Company N.A, as Trustee, to institutional investors at a price of 100% of the principal amount thereof. Nicor Gas realized aggregate proceeds from the sale of these 4.70% Series of \$50,000,000. The net proceeds from this issuance were used to replace the \$50,000,000 5.37% Series due February 01, 2009.


2. The expenses incurred by the Company in connection with the issuance, sale and delivery of the foregoing \$50,000,000 aggregate principal amount of bonds have amounted in total, as of September 30, 2009 to \$576,129 as follows:

3. No capital stock was proposed by Nicor Gas for issuance. In addition, there are no amount or amounts of proceeds from the foregoing sales and issuances remaining unapplied to the purpose or purposes specified in the Commission's Final Order. There may be additional issuance and sale expenses incurred or payable after September 30, 2009 to be accounted for in subsequent quarterly reports.
