**PETITION OF THE PEOPLE OF THE STATE OF ILLINOIS
FOR LEAVE TO INTERVENE**

The People of the State of Illinois, by Lisa Madigan, Attorney General of the State of Illinois (“the People”), pursuant to the Rules of Practice of the Illinois Commerce Commission (“the Commission”), 83 Ill. Admin. Code 200.200 and the Attorney General Act, 15 ILCS 205/6.5(d), petition for leave to intervene and be made a party in the above captioned proceeding. In support of this Petition, the People of the State of Illinois state the following:

1. The Attorney General represents consumers of electric services within the State of Illinois before this Commission.
2. The Attorney General has a duty to ensure that Illinois consumers receive adequate, safe, reliable, cost-effective electric services, and pay just and reasonable rates for those services. 15 ILCS 205/6.5(a).
3. The People of the State of Illinois, as electric consumers, will be affected by any order entered by the Commission in this proceeding.
4. The Attorney General Act provides that “the Attorney General shall be a party as a matter of right to all proceedings, investigations, and related matters involving the provision of ...electric... services before the Illinois Commerce Commission.” 15 ILCS 205/6.5(d).


