PETITION FOR CONFIDENTIAL TREATMENT

BLUESTAR ENERGY SERVICES, INC., ("BlueStar"), hereby petitions the Illinois Commerce Commission ("Commission") to protect from disclosure for not less than five years highly confidential and proprietary information contained in BlueStar's report, pursuant to 83 Ill.Adm.Code §451.770, stating the total annual kilowatt-hours delivered and sold to retail customers in 2010. In support of its Petition, BlueStar states as follows:


1. BlueStar is an ARES authorized to service all eligible retail electric customers in Illinois.
2. On or about February 26, 2010, BlueStar served by U.S. Mail its annual Kilowatt hour report with the Commission. This report contains trade information and market sensitive information regarding BlueStar's customers in Illinois. This information is both proprietary and confidential, and the public disclosure of this information would be detrimental to BlueStar.
3. Section 451.60 of the Illinois Administrative Code provides for protection of such information. Similarly, disclosure of trade secrets is exempted from the Illinois Freedom of Information Act (5 ILCS 140/7(g)).

4. BlueStar has submitted redacted versions of these documents to the Chief Clerk as well.

WHEREFORE, Applicant BlueStar Energy Services, Inc. respectfully requests that the Commission enter an Order protecting BlueStar's report filed pursuant to 83 Ill.Adm.Code §451.770 from public disclosure in any form for a period of not less than five years.


