1 SECRETARY SNYDER: Any opposed? The vote is 2
2 to zero. The minutes are approved.

3 We will use this 2 to 0 roll call vote
4 for the remainder of the agenda unless otherwise
5 noted.

6 MC-1 is Docket 28748 Sub 12. This is
7 a request for temporary suspension of the Certificate
8 of Public Convenience and Necessity/Public Carrier
9 Certificate by Jack Raffee, R-A-F-F-E-E, and Sons,
10 Inc. Secretary Snyder recommends granting the
11 request. Is there any discussion?

12 MEMBER McCORMICK: No.

13 SECRETARY SNYDER: Any objections?

14 MEMBER McCORMICK: No.

15 SECRETARY SNYDER: Hearing none, the request is
16 granted.

17 MC-2 is Docket 58061 Sub 7. This is a
18 request for a non-hearing transfer/acquisition of a
19 Certificate of Public Convenience and
20 Necessity/Public Carrier Certificate from Joseph R.
21 Moore, M-O-O-R-E, doing business as Moore's Furniture
22 and Piano Movers to Moore's Furniture and Piano

1 Movers, Inc. Secretary Snyder recommends granting
2 the request. Is there any discussion?

3 MEMBER McCORMICK: No.

4 SECRETARY SNYDER: Are there any objections?

5 MEMBER McCORMICK: No.

6 SECRETARY SNYDER: Hearing none, the request is
7 granted.

8 MC-3 is Docket 85114 Sub 3. This is a
9 request for temporary suspension of a Certificate of
10 Public Convenience and Necessity/Public Carrier
11 Certificate by P.M. Moving Incorporated. Secretary
12 Snyder recommends granting the request. Is there any
13 discussion?

14 MEMBER McCORMICK: No.

15 SECRETARY SNYDER: Any objections?

16 MEMBER McCORMICK: No.

17 SECRETARY SNYDER: Hearing none, the request is
18 granted.

19 Finally, MC-4 is Docket 136144 Sub 4.
20 This is a request for a non-hearing

1 for a company by the name of The Professionals, Inc.,
2 involving a change through acquisition of stock of
3 ownership from wife to husband. Secretary Snyder
4 recommends granting the request. Is there any
5 discussion?

6 MEMBER McCORMICK: There isn't any reason why
7 we would question the transfer?

8 SECRETARY SNYDER: No. Because of the fact
9 that the form has been completed by husband and wife
10 and signed by both, we have to assume that there is
11 no divorce or anything like that going on with this.

12 MEMBER McCORMICK: Right. That was my only
13 question.

14 SECRETARY SNYDER: Yeah, I would question that,
15 too, because I have seen situations where there is
16 some nasty stuff going on that you don't know about.

17 MEMBER McCORMICK: I have no objections then.

18 SECRETARY SNYDER: Okay. No objections,
19 hearing none, the request is granted.
