**CLARIFYING PETITION FOR CONFIDENTIAL TREATMENT**

Exelon Energy Company ("Exelon") pursuant to the Administrative Law Judge's Ruling of April 1, 2010, hereby submits its Verified Compliance Filing Clarifying Petition for Confidential Treatment:

1. The Administrative Law Judge asked for a statement of how disclosure of the Annual Kilowatt-hour Report would be detrimental to Exelon. In response, Exelon further states that disclosure of the information contained in its Annual Kilowatt-hour Report would reveal sensitive confidential and proprietary information regarding Exelon's market share within the various utility footprints. Disclosure of this information would cause Exelon competitive harm because this type of competitive data is used to formulate current and future business plans as well as would give competitors information about Exelon's operations that is not available in any other public forum.
2. Finally, the Administrative Law Judge asked for "an explanation of why five years of confidential treatment is warranted for the information, as opposed to a shorter

period, such as two years.” In response, and upon further reflection, Exelon states that a period of two (2) years of confidential treatment for the information at issue would be sufficient and therefore amends its request to confidential treatment for a period of two years.




