VERIFIED PETITION OF ACCESS ONE, INC.
FOR PROPRIETARY TREATMENT OF ITS 2009 ANNUAL REPORT

Access One, Inc. ("Access One"), by its attorneys, hereby petitions the Illinois Commerce Commission ("ICC") for emergency relief to protect Petitioner's 2009 Annual Report from disclosure for not less than two (2) years in order to protect the Company's highly proprietary information contained therein. In support of its Petition, Access One states as follows:


1. Access One has licenses from this Commission to provide facilities based and resold local exchange service and interexchange service in Illinois.
2. Access One is required to file its 2009 Annual Report with the ICC pursuant to 220 ILCS 5/5-109 of the Illinois Public Utilities Act.
3. Access One's Annual Report contains highly proprietary and confidential commercial and financial information. The disclosure of proprietary information to competitors or potential competitors would be detrimental to Access One and provide an unfair advantage to Access One's competitors.

4. The telecommunications industry is highly competitive, and it is imperative that the proprietary information contained in Access One's 2009 Annual Report receive confidential treatment for at least two (2) years following the issuance of an Order by this Commission.
5. Section 7 of the Illinois Freedom of Information Act (5 ILCS 140/7(g)) exempts from public disclosure "trade secrets and commercial or financial information... where the trade secrets or information are proprietary, privileged or confidential." Access One's 2009 Annual Report is protected by this exemption.
6. Access One seeks an Order from this Commission, without hearing, protecting the entirety of Access One's 2009 Annual Report from disclosure for a period not less than two (2) years.

WHEREFORE, Access One respectfully requests that this Commission enter an Order, without hearing, protecting the entirety of Access One's 2009 Annual Report from disclosure for a period not less than two (2) years.


