Verified Supplemental Compliance Filing

Now comes Energy Purchasing Services, Inc. and hereby submits this Verified Supplemental Compliance Filing pursuant to the May 25, 2010, Notice of Administrative Law Judge's Ruling. In support thereof Energy Purchasing Services hereby states the following:

The Administrative Law Judge has required that Energy Purchasing Services file this Verified Supplemental Compliance Filing in response to the May 25, 2010 notice, indicating that the ABC Annual 2010 Recertification Report and the verified financial statement have been submitted to the Commission.

Energy Purchasing Services, Inc. states that it is requesting proprietary treatment of its ABC Annual 2010 Recertification Report under 83 Ill. Admin. Code 454 (#09-0493) and the 2009 EPS Income Statement.

The information in the reports would be used by the EPS competitors in a manner that would harm the business operations of Energy Purchasing Services. Competitors would be able to determine the number of EPS clients, and then would be able to extrapolate the amount of service fees charged to the Energy Purchasing Services clients.

This information will give an unfair advantage to the competitors of Energy Purchasing Services, Inc. and would substantially harm the business operations of EPS.

Therefore, Energy Purchasing Services, Inc. requests that the information contained herein remain proprietary for a period of two years. At the end of the two-year period, the information contained in the reports would not be able to be used to harm the business operations of Energy Purchasing Services, Inc. At that time, EPS business would be substantively changed, and therefore, the information that can be garnered from the reports would be of no harm to EPS operations.

Energy Purchasing Services, Inc. has not requested proprietary treatment of the information with other agencies, as no other agencies have requested this information.

**Response to Administrative Law Judge's Ruling, Docket 10-0313
Energy Purchasing Services, Inc.**

1) "EPS must submit a proper recertification report under 83 Ill. Adm. Code 454, "Licensure of Retail Electric Agents, Brokers and Consultants"."

The ABC Recertification Report under 83 Ill. Adm. Code 454 for Energy Purchasing Services, Inc. is enclosed.

2) "...the redacted confidential version of EPS' recertification report shall contain the actual names of each retail electric supplier with which it had any contractual relationship during the prior calendar year."

Energy Purchasing Services, Inc had no contractual relationships with any retail electric supplier during 2009. Energy Purchasing Services, Inc. has contractual relationships with its clients only.

3) "...the redacted public version of the recertification report must reflect the entire recertification report, the only difference from the unredacted confidential version of the report being the clearly marked redacted information in the public version."

Please see the revised redacted public version of the recertification report, which is enclosed.

4) "EPS must submit a verified compliance filing in this docket (not a letter) by June 4, 2010 explaining why the redacted information warrants confidential treatment. Specifically, EPS must explain what particular harm it fears may occur, and how that harm may occur, if the redacted information became available to the public. The compliance filing shall also explain why two years of confidential treatment is warranted, as opposed to some other time period.


