



Appellate Court of Illinois, First Judicial District, from the following orders of the Illinois Commerce Commission (the “Commission” or “ICC”) in *In re North Shore Gas Company: Proposed General Increase In Natural Gas Rates* and *In re The Peoples Gas Light and Coke Company: Proposed General Increase In Natural Gas Rates*, ICC Docket Nos. 09-0166 and 09-0167 (Consolidated): the Order dated January 21, 2010, and served on January 22, 2010, which approved certain modifications to the Utilities’ tariff sheets effecting a general increase in rates, and revising other terms and conditions of service for the Utilities; the order and corrected order (the first entitled “Notice of Commission Action” and the second entitled “Notice of Corrected Commission Action”) each dated and served on March 11, 2010, that denied the applications for rehearing filed with the Commission by the Utilities; and the Order on Rehearing dated and served on June 2, 2010. The March 11th order, as corrected, granted as to the subject of “Rider ICR”, and otherwise denied, the respective applications for rehearing filed by the Illinois Attorney General’s Office and the Citizens Utility Board, and it granted the application of the City of Chicago, which was limited to the subject of Rider ICR. The June 2nd order fully resolved the subject as to which rehearing had been granted. The Utilities seek relief reversing in part the above January 21st and March 11th orders of the Commission and remanding this matter to the Commission for appropriate further proceedings and the entry of an appropriate order on remand. The Utilities appeal from the June 2nd order in that it incorporates the prior orders.


