Know All Men By These Presents:

JOHN E. WILKINSON

That the Grantor JOHN E. WILKINSON of Illinois,
being the owner of the property hereinafter described, in consideration of the
sum of One Dollar (\$1.00) and other good and valuable considerations in hand paid
by the Public Service Company of Northern Illinois and Middle States Telephone
Company of Illinois, corporations organized and existing under the law of the
State of Illinois, receipt of which is hereby acknowledged, hereby grant to the
said Public Service Company of Northern Illinois and Middle States Telephone Co.,
their successors and assigns, jointly and severally, the right, permission, and
authority to construct, maintain and renew their poles, wires, and necessary
fixtures for the transmission and distribution of electricity for heat, light,
power, telephone, and other purposes, together with the right of access to the same
for the maintenance thereof, and also to trim from time to time such trees, bushes
and saplings as may be reasonably required for the construction and efficient oper-
ation of said poles, wires and necessary fixtures, upon, and over the
property described below,
