VERIFIED PETITION TO INTERVENE

Interstate Gas Supply of Illinois, Inc. ("IGS"), by and through its counsel, pursuant to 83 Illinois Administrative Code Section 200.200, hereby petitions the Illinois Commerce Commission ("Commission") to intervene in the above-captioned proceeding. In support of this Petition, IGS states as follows:

1. IGS is currently licensed by the Commission as an Alternative Gas Supplier and is an active participant in the Illinois competitive natural gas market, providing service to residential and commercial customers in northern Illinois. IGS is also an active participant in competitive markets in six other states and in a total of fourteen public utility service areas.

2. As a provider of service to retail gas customers in Illinois, IGS has a strong interest in the continued fair and consistent development of an efficient and robust competitive energy marketplace in Illinois, particularly with respect to fairness and consistency between the rules regulating both electric and natural gas markets. As such, IGS has a substantial interest in this proceeding, and no other party to this proceeding can adequately represent IGS's interests.

3. IGS wishes to participate as an active party in the instant proceeding and to present its position on the issues. Granting of the instant Petition to Intervene will not delay this proceeding.
