ORDER

By the Commission:

On July 29, 2010, Progressive Energy Group LLC (“Petitioner”) filed with the Illinois Commerce Commission (“Commission”) a verified Petition to de-certify as an alternative gas supplier (“AGS”) in Illinois.

Petitioner was granted authority to operate as an AGS on December 3, 2008, in Docket 08-0478. In support of its Petition, Petitioner states that it does not serve any customers as an AGS in Illinois and has not marketed as an AGS to any potential Illinois customers. Petitioner also states that it does not plan to provide service as an AGS in the future in Illinois and has decided to exit the Illinois market due to a change in business plans.

No parties intervened in this proceeding. Since all facts necessary for the Commission to grant the relief requested are contained in the Petition, the Administrative Law Judge waived the hearing in this matter.

The Commission having reviewed the entire record herein and being fully advised in the premises, is of the opinion and finds that:

- (1) the Commission has jurisdiction over Petitioner and the subject matter herein;
- (2) Petitioner was granted a Certificate of Service Authority in Docket 08-0478 to operate as an AGS in the service areas of Northern Illinois Gas Company, d/b/a Nicor Gas Company, the Peoples Gas Light and Coke Company, and North Shore Gas Company;
- (3) on July 29, 2010, Petitioner filed a Petition to de-certify as an AGS authorized to operate in Illinois pursuant to its Certificate of Service Authority issued in Docket 08-0478;

- (4) Petitioner does not currently provide service as an AGS to customers in Illinois, therefore, granting the relief requested will not deprive Illinois customers of any necessary public utility service and is not otherwise contrary to the public interest; thus the Petition should be granted; and
- (5) Petitioner's compliance report filed on March 10, 2010 should be considered its final compliance report.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that Progressive Energy Group LLC's request to de-certify as an alternative gas supplier is hereby granted and its Certificate of Service Authority issued in Docket 08-0478 is cancelled.

IT IS FURTHER ORDERED that Progressive Energy Group LLC's compliance report filed on March 10, 2010 shall be considered its final compliance report.

IT IS FURTHER ORDERED that subject to the provisions of Section 10-113 of the Public Utilities Act and 83 Ill. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.
