AMENDED PETITION FOR CONFIDENTIAL TREATMENT

On September 9, 2010, BlueStar Energy Services, Inc. d/b/a BlueStar Energy Solutions ("BlueStar") filed its supplement to its Annual Renewable Portfolio Standard Compliance Report for the compliance period from June 1, 2009 to May 30, 2010 (the "Report") with the Illinois Commerce Commission (the "Commission"). BlueStar hereby submits its Amended Petition for Confidential Treatment (this "Petition") to protect from disclosure, for a period of two years, highly confidential and proprietary information included in the Report stating certain load information for the relevant reporting period. In support of this Petition, BlueStar states as follows:

1. BlueStar is an ARES authorized to service all eligible retail electric customers in Illinois.
2. On or about September 9, 2010, BlueStar served the Report on the Commission by overnight mail (a redacted copy of the Report is attached hereto and made a part hereof as Exhibit A). The Report contains trade information and market-sensitive information regarding BlueStar's load served in Illinois in that it identifies the total load served by BlueStar during the relevant reporting period. This is confidential and highly market-sensitive information that provides insight into BlueStar's operations that would not otherwise be available to BlueStar's competitors. The specific information for which BlueStar seeks confidential and proprietary treatment is the total kilowatt hours delivered and sold to retail customers within each utility service territory (and the calculations therefrom), the alternative compliance payment, the quantity of renewable energy credits retired and the List of Illinois Retail Customers Who Received Electricity That Was Not Supplied Pursuant to Contracts Executed or Extended After March 15, 2009.

3. This information is indicative of market share, and the public disclosure of this information would be detrimental to BlueStar. Disclosure of this information would cause BlueStar competitive harm because this type of competitive data is used to formulate current and future business plans, as well as would give competitor RESs information about BlueStar's operations that is not available in any other public forum. BlueStar does not provide that information to any individual outside of its employ and permits access to that information by its employees only as necessary for job function. BlueStar believes a time period of two years is sufficient protection for the information relating to its load served, as the competitive usefulness of such information for planning purposes is no longer as relevant.


4. Section 455.20(b) of the Illinois Administrative Code provides for protection of such information. Similarly, disclosure of trade secrets is exempted from the Illinois Freedom of Information Act (5 ILCS 14017(g)).

5. BlueStar has submitted redacted versions of these documents to the Chief Clerk as well.

WHEREFORE, BlueStar respectfully requests that the Commission enter an Order protecting the Report filed pursuant to 83 Ill. Adm. Code §455 from public disclosure in any form for a period of not less than two years.
