**AMENDMENT TO THE EASEMENT PROVISIONS
 OF THE PLAT OF CHINQUAPIN RIDGE ESTATES**

The undersigned, being all of the owners of the various lots in Chinquapin Ridge Estates subdivision, Rockvale Township, Ogle County, Illinois hereby declare the following amendment to the Easement Provisions as shown on the Plat of said subdivision recorded in File A of Plats at Page 100 as Document No. 1992-8158 and recorded on July 9, 1992.

Easement Provisions are hereby amended to read as follows:

An easement for electric service, communication service, water service and cable television is hereby reserved for and granted to Commonwealth Edison, G.T.E. Telephone Company of Illinois, Rockvale Corporation and any other franchise of Ogle County, also their respective successors and assigns, in all streets, alleys and other public ways and places shown on this plat, also the area as shown by dotted lines on the plat and marked "Utility Easement", to install, lay, construct, relocate, remove, renew, operate and maintain conduits, cables, pipes, poles, and wires, overhead and underground, with all necessary braces, guys, anchors and other equipment for the purpose of serving the subdivision and other property with telephone, water and electric services; also is hereby granted the right to use the streets for said purposes, upon approval of appropriate highway authority the right to overhang all lots with aerial service wires to serve adjacent lots, and right to enter upon the lots at all times to install, lay, construct, renew, operate and maintain within said easement area, said conduits, cables, pipes, poles, wires, braces, guys, anchors and other equipment; and finally the right is hereby granted to cut down and remove or trim, or keep trimmed all trees, shrubs or saplings that interfere with any of the said public utility equipment.

The remaining provisions of the Easement Provisions shall remain unchanged.

This amendment shall be properly recorded against the plat of subdivision such that this amendment shall run with the land of each of the lots of said subdivision, and shall be effective as against each owner, their successors, heirs, assignees and all others who take possession or control of said lands subsequent to the filing hereof. Each lot owner has indicated their approval of the above amendment as evidenced by their signature below.
