

STAFF'S ANSWER TO THE PETITION

Now comes the Staff of the Illinois Commerce Commission (Staff) and in support of its Answer to the Naperville 9-1-1 System's Petition for Approval of a Modification to Illinois Commerce Commission License #92-0158, states the following:

1. The Naperville 9-1-1 System received an order to operate its Enhanced 9-1-1 System from the Commission on May 28, 1992, in Docket 92-0158.
2. On October 28, 2010, the Naperville 9-1-1 System filed a Petition for Approval of a Modification to Illinois Commerce Commission License #92-0158 in which it requests to change its backup public safety answering point (PSAP) to the Aurora PSAP in the Kane County 9-1-1 System.
3. The Aurora PSAP, located at 1200 Indian Trail Road, Aurora, IL, meets all the requirements for a backup PSAP as prescribed in Section 725.505(i) of Illinois Administrative Code Part 725 – Standards of Service Applicable to 9-1-1 Emergency Systems.
4. An intergovernmental agreement has been signed by both the Naperville 9-1-1 System and the Kane County 9-1-1 System for the provisioning of backup 9-1-1 services. This agreement was included in the Petition.
5. Staff has thoroughly reviewed the Naperville 9-1-1 System's Petition for Approval of a Modification to Illinois Commerce Commission License #92-0158 and supports the petitioners' request for modification. In addition, Staff supports waiving a hearing in this docket.






