PETITION

NOW COMES A.R.C. Networks, Inc. d/b/a InfoHighway ("A.R.C.") and petitions this Honorable Commission for withdrawal of its Certificate of Interexchange Service Authority, and cancellation of its associated interexchange services tariff. In support of this Petition, A.R.C. states as follows:

1. A.R.C. holds a Certificate to provide intrastate telecommunications services in Illinois pursuant to this Commission's Order in Docket No. 96-0162. In compliance with that Order, A.R.C. filed tariff Illinois C.C. No. 1 setting forth the rates, rules and regulations for its intrastate services.

2. A.R.C. does not actively market intrastate, interexchange telecommunications services in the State of Illinois.

3. As a result of the natural attribution of customers, A.R.C. currently has no intrastate, interexchange telecommunications services customers in the State of Illinois. Accordingly, no customers exist to whom notice of discontinuance of interexchange services might be served. A.R.C. therefore respectfully requests that the Notice of Discontinuance required by Section 13-406 of the Public Utilities Act be waived.

WHEREFORE, A.R.C. Networks, Inc. d/b/a InfoHighway respectfully requests that this Honorable Commission:

A. Grant its Petition to Withdraw the Certificate of Interexchange Service Authority granted in Docket No. 96-0162;

- B. Grant its Petition to cancel A.R.C. Networks, Inc. d/b/a InfoHighway Illinois C.C. Tariff No 1;
- C. Grant its Request for Waiver of the Notice of Discontinuance required by Section 13-406 of the Public Utilities Act;
- D. Hold any hearings which might be necessary in connection with this filing on a telephonic basis;
- E. Grant any other appropriate relief.


