EIGHTH REPORT

To the Commission:

On April 21, 2010, the Commission issued its Order in docket 09-0268 approving the transaction between Frontier Communications Corporation and Verizon Communications Inc. The transaction closed effective July 1, 2010. In accordance with the Commission's approval Frontier North, Inc., formerly Verizon North Inc., is now a subsidiary of Frontier Communications Corporation. In compliance with 83 Illinois Administrative Code Part 240, Frontier North Inc. (as successor to Verizon North Inc.) submits the following report with respect to the issuance and sale of the securities, and the application of proceeds thereof, approved by the Commission's October 15, 2008 Order entered in this docket:

1. No transactions within the scope of 83 Illinois Administrative Code Section 240.20 occurred during the 3rd Quarter of 2010.
2. Frontier North Inc. has remaining authority from the Commission to sell up to \$980,000,000 of new debt through December 31, 2010.
