1. In August 2020 I received an electric bill that was suddenly outrageous. It stated that I owed \$1,643.18 instead of the less than \$40.00 per month.
2. I asked ComEd for the reason and they sent me a billing that showed that I used huge amounts of electric in Nov. & Dec. 2009 and Jan. & Feb. 2010. I would have questioned these billings if they gave them to me when they allege that I was using those high amounts.
3. These billings state that I have a deman meter that shops using heavy equipment use. I do not use any power tools or heavy equipment. A light is all I use other than truck heaters.

Please clearly state what you want the Commission to do in this case:

I want my billing corrected to reflect the amount of electric that I actually use.


