ARTICLES OF INCORPORATION.

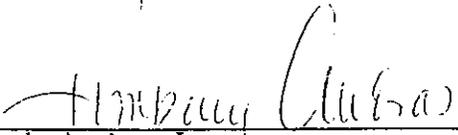

SIXTH: The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California Law.

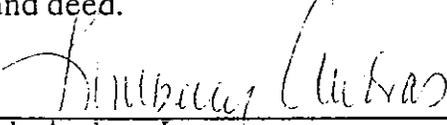

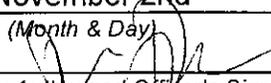
