## Essential Agreement Information

I CHOOSE U.S. Energy Savings Corp. ("USESC") to be my supplier of natural gas ("gas") for a Term of  4 years or  5 years. I UNDERSTAND AND ACCEPT:

- a) This Agreement offers price stability and does not guarantee financial savings. It is with USESC, an alternative gas supplier, and not with my local Utility.
- b) USESC will supply gas (and the number of GEOgas units I choose) to the Location, at the Price and for the Term I choose. I will pay the related charges.
- c) This Agreement only covers the cost of gas (and GEOgas, if I choose it). I will also be responsible for regulated delivery, transportation, and other charges (or credits) billed by my Utility. Charges (credits) upon switching to an alternative gas supplier, such as USESC, include the following: If NICOR is my Utility, in addition to the Price, I will pay a Customer Select Charge (it averaged 1.85¢/therm from Jan. to July 2008) and receive a Transportation Service Credit (it is 1.02¢/therm in 2008). If either Peoples or North Shore is my Utility, in addition to the Price, I will pay an Aggregation Balancing Gas Charge (it averaged 3.4¢/therm from Jan. to July 2008 for Peoples, and 3.4¢/therm from Jan. to July for North Shore) and pay reduced Utility distribution charges (Peoples commercial - .9¢/therm; Peoples residential - 2.61¢/therm; North Shore commercial - 48¢/therm; and North Shore residential - 45¢/therm). Depending on my municipality, I may also be eligible for a local tax reduction on the supply portion of my bill. I have read and understand paragraph 7, "Charges".
- d) Before the Term ends, this Agreement can be automatically renewed, and I can Blend & Extend this Agreement.
- e) If I cause this Agreement to end early, I will owe USESC an Exit Fee capped at \$75 for each year left in the Term (for example: if I end this Agreement with three years left in the Term, I will pay an Exit Fee of up to \$225). If I signed for GEOgas, a GEO Exit Fee may also apply. I have read and understand paragraph 11, "Exit Fees".
- f) I will be enrolled in USESC's budget billing (level payment) plan; if I wish to opt out, I must check here .
- g) I have received a completed and signed copy of this Agreement, a Notice of Cancellation, and have been advised orally of my right to cancel.

I, THE CUSTOMER, HAVE THE RIGHT TO CANCEL THIS AGREEMENT AT ANY TIME PRIOR TO MIDNIGHT OF THE THIRD BUSINESS DAY AFTER THE DATE OF THIS AGREEMENT. USESC GIVES ME AN EXTENDED CANCELLATION PERIOD OF 30 DAYS FROM THE DATE OF MY FIRST BILL UNDER THIS AGREEMENT. I HAVE READ THE ATTACHED NOTICE OF CANCELLATION FORM FOR AN EXPLANATION OF THIS RIGHT.
