COMMONWEALTH EDISON COMPANY’S
MOTION FOR EXTENSION OF TIME


Commonwealth Edison Company (“ComEd”), by its attorneys, respectfully moves the Administrative Law Judge (“ALJ”), pursuant to 83 Ill. Adm. Code § 200.190, for an extension of time to file exceptions and replies in this proceeding. In support of its Motion, ComEd states:

1. On August 31, 2010, ComEd filed a Petition (“Petition”) asking the Illinois Commerce Commission to approve an Alternative Regulation Program pursuant to Section 9-244 of the Public Utilities Act (220 ILCS 5/9-244).

2. The Administrative Law Judge entered her Proposed Order on March 25, 2011. The dates for filing exceptions and replies are April 13, 2011 and April 20, 2011, respectively.

3. ComEd respectfully requests an extension of time to file exceptions and replies until April 15, 2011 and April 22, 2011, respectively. Since the Proposed Order in this proceeding was entered, Counsel for ComEd has been engaged in preparing Brief on Exceptions in Docket No. 10-0467, ComEd’s rate case, which was due on April 11, 2011 and is currently engaged in preparing Reply Brief on Exceptions, which is due on April 18, 2011. Because the extension applies to Staff, ComEd and all Intervenors, the extension prejudices no party, and is reasonable.

WHEREFORE, for all of the reasons that are set forth above, Commonwealth Edison Company respectfully moves the Administrative Law Judge to grant its Motion for Extension of Time to file exceptions and replies in this proceeding.
