MOTION TO WITHDRAW CERTIFICATE

Working Assets Funding Service, Inc. ("Working Assets"), pursuant to 83 Ill. Adm. Code Part 200.190, respectfully submits this Motion to Withdraw its Certificate of Authority to Operate as a Reseller of Local Exchange Telecommunications Services in the State of Illinois.

1. On March 17, 2004, Working Assets was Certificated to Operate as a Reseller of Local Exchange Telecommunications services throughout the State of Illinois pursuant to the Commission's Order in Docket No. 03-0761.

2. In compliance with that Order, Working Assets filed its Ill. C.C. Tariff No.1, initially effective August 24, 2004.

3. Working Assets has no local exchange customers in Illinois and no longer intends to retain its Certificate of Authority to Operate as a Reseller of Local Exchange Telecommunications Service in the State of Illinois.

4. Upon due consideration, Working Assets now moves to cancel and withdraw its Local Exchange Telecommunication Service Certificate and Tariff, without prejudice.

5. No parties will be prejudiced by withdrawal of Working Assets' Local Exchange Telecommunications Certificate and Tariff.

5. Working Assets also has a Certificate of Authority to Operate as a Reseller of Interexchange Telecommunications Service in the State of Illinois, pursuant to the Commission's Order in Socket No. 91-0306, and associated Ill. C.C. Tariff No. 2. The instant Motion to Withdraw does *not* apply to Working Assets' Interexchange Telecommunications Service Certificate or its Tariff No. 2, which should remain valid.

WHEREFORE, Working Assets respectfully requests an Order granting its Motion to Withdraw Certificate without prejudice, and for such other and further relief as deemed appropriate.
