On May 13, 2011, NextEra Energy Services Illinois, LLC ("NextEra") filed an Application to amend its existing certificate of service authority to authorize NextEra to provide alternative retail electric service to all customers in the service territories of Commonwealth Edison Company, Central Illinois Light Company, d/b/a AmerenCILCO ("CILCO"), Central Illinois Public Service Company, d/b/a AmerenCIPS ("CIPS"), and Illinois Power Company, d/b/a AmerenIP ("IP").




