

I, Melcina Blanton hereby dispute Com-Ed Billings of Service from 4/19/2011 to 5/18/2011, 3/21/2011 to 4/19/2011, 2/18/2011 to 3/21/2011, 1/20/2011 to 2/18/2011, 12/17/2010 to 1/20/2011, 11/16/2010 to 12/17/2010, 10/18/2010 to 11/16/2010, 9/16/2010 to 10/18/2010, 2/18/2010 to 3/22/2011, 1/20/2010 to 2/18/2010, 12/17/2009 to 1/20/2010, 12/17/2010 to 1/20/2010, 11/16/2009 to 12/17/2009, 10/16/2009 to 11/16/2009, 9/17/2009 to 10/16/2009, 8/19/2009 to 9/17/2009; and May 16, 2011 deposit of money, on the following grounds:

1. Com-Ed knowingly and intentionally committed falsification of records and fraudulent billings and failed to present factual actual data of each month service to support the billing.

2. Com-Ed knowingly and intentionally with intent to commit extortion demanded deposit of money base on the fraudulent billings of service.

Relief

WHEREFORE, Plaintiff pray Illinois Commerce Commission for Order as Follows:

- a). The demise property was boarded-up from date of possession 6/25/2009 to 5/19/2010 and Com-Ed billing for One Alarm System the only thing using electric in the property is \$12.00 (twelve dollars) a month and legitimate for the afore-said period and should stand.
- b). Com-Ed billing for Hot Summer Months Electric Usage Peak Period of the property, 5/19/2010 to 10/18/2010 averaged not more than \$120.00 (one hundred twenty dollars) a Month; and for fairness to parties of the cause and peace this is the amount due Com-Ed for each month of the period 5/19/2010 to date and payment be made immediately.

- c). That if Com-Ed had not engage in falsification of electric usage data of the property and fraudulent billings activity and present Meter Actual Electric Usage Data with its truthful honest Billing, Plaintiff will make payment immediately with no sweat. For cause, Com-Ed fraudulent interest charges and deposit demand resulting from its fraudulent billings is null and void.
- d). Whereas the Meter Electric Usage Data of a Month Billing Cycle should and must be the same Usage in the Month Billing. This is not the case. Something is wrong and phony. Therefore, Com-Ed should install Brand New Meter starting with Zero Settings to assure honesty and integrity of Electric Usage Data and Billing.
