MOTION FOR REHEARING

NOW COMES, NET TALK.COM, Inc. by and through its attorneys, the Law Offices of THOMAS B. CAMERON and for its Motion for Rehearing state as follows:

1. On February 9th, 2011, the Illinois Commerce Commission ("Commission") entered a citation order against NET TALK.COM, Inc. for failure to file the annual report for 2009.
2. On May 3rd, 2011, NET TALK.COM, Inc. filed its Motion to Dismiss this proceeding based upon its filing of the annual report in the form attached hereto.
3. On May 6th, 2011, the staff of the Illinois Commerce Commission filed its Response to Motion to Dismiss the same not opposing the Respondent's Motion.
4. On May 24th, 2011, the Commission revoked the Certificate of Authority previously granted NET TALK.COM, Inc. in Docket 08-0580.
5. Respondent, on information and belief, concludes that the Commission was unaware of Respondent's compliance with the statutory requirements, the existence of Respondents pending Motion to Dismiss or with the Illinois Commerce Commission staffs own Response to the Motion at the time of the entry of the order on May 24th, 2011.
6. Respondent seeks rehearing, asking that the Commission hear its Motion to Dismiss and pointing out that no party would be prejudiced if this Motion were to be granted.

WHEREFORE, NET TALK.COM, Inc. asks for rehearing and respectfully requests that the Commission grant his original Motion to Dismiss nunc pro tunc to May 24th, 2011.
