Cellco Partnership (a Delaware general partnership), Chicago SMSA Limited Partnership (a Delaware limited partnership), Chicago 10 MHZ LLC (a Delaware corporation), CyberTel Cellular Telephone Company (a Delaware limited partnership), GTE Wireless of the Midwest Incorporated (an Indiana corporation), Rockford MSA Limited Partnership (an Illinois limited partnership), Illinois RSA 1 Limited Partnership (an Illinois limited partnership), Illinois RSA 6 and 7 Limited Partnership (a Delaware limited partnership), and Illinois SMSA Limited Partnership (an Illinois limited partnership), (hereinafter "Petitioners"), respectfully represent:


1. Petitioners currently provide domestic commercial mobile radio service to the general public in Illinois.
2. Cellco Partnership is the ultimate controlling entity of all of the Petitioners.
3. Petitioners are filing concurrently with this Petition an Annual Report for the year ended 2000 pursuant to Section 5-109 of the Illinois Public Utilities Act.
4. Information contained in the Petitioners' Annual Reports relates to the provision of competitive commercial mobile radio service to the general public in the areas of service in Illinois. The commercial mobile radio service industry is a highly competitive business and information such as that contained in an Annual Report is proprietary and commercially sensitive. The disclosure of such information to Petitioners' competitors could provide the competitors with a competitive advantage.
5. Petitioners seek entry by this Commission of an order allowing proprietary and confidential treatment of the information contained in the Petitioners' Annual Reports for the year ended 2000 as filed with the Commission.

WHEREFORE, Petitioners pray that the Commission enter, without further hearing, an order allowing the confidential and proprietary treatment of Petitioners' Annual Reports for the year ended 2000.


