Reliant Energy Northeast LLC ("REN") meets the Technical and Managerial Requirements under Part 451.230 and 451.330 as demonstrated by the following:

Reliant Energy Northeast LLC and NRG Power Marketing LLC are both members of PJM, and both are wholly-owned subsidiaries of NRG Energy, Inc. NRG Power Marketing LLC purchases 100% of its physical electric energy *on behalf of Reliant Energy Northeast LLC* from PJM for delivery of the service territories of the utilities for which the Applicant is seeking a certificate. All individuals listed below are employed by NRG Energy, Inc. or one of its wholly-owned affiliates.

The following individuals are the principal persons responsible for obtaining and arranging the wholesale supply, have at least four years experience buying and selling power and energy in wholesale markets, and at least one year of scheduling experience working for an entity that is either a member of PJM, a market participant in the Midwest ISO:

- Tom Wettlaufer
- Alex LaGuardia

Tom Wettlaufer attended North Dakota State College of Science; his career in the power business began in 1979 as a Power System Operator. Tom is currently NRG's PJM Portfolio Director and has been in this position since January 2009. In this capacity he is responsible for managing the commodity price risk of the PJM fleet and directing the day to day management of NRG's PJM generation portfolio and load obligations. His experience in these areas has entailed all areas of the Eastern Interconnection.

Alex LaGuardia attended Rutgers University and has been employed in the power marketing business since 1999; he is currently the PJM Asset Manager and has been in this position since July of 2006. Alex is responsible for the day to day management of NRG's PJM generation portfolio and load obligations, which include but are not limited to day ahead scheduling, outage management, RPS management and bill reconciliation. His experience in these areas has been limited to the PJM footprint to date.
