PETITION

Zayo Group, LLC (“Zayo”), as the successor in interest to Zayo Bandwidth, LLC¹ (“ZB” and together with Zayo, the “Company”) and by its undersigned counsel, hereby files this verified Petition for Withdrawal of Zayo Bandwidth, LLC’s Certificates of Interexchange Service Authority and Exchange Service Authority. In support of this Petition, the Company states as follows:

1. ZB was a Delaware limited liability company. The Company’s principal offices are currently located at 400 Centennial Parkway, Suite 200, Louisville, Colorado 80027.
2. ZB is authorized by the Commission to provide resold and facilities-based local exchange and interexchange telecommunications services pursuant to Certificates granted in Docket No. 09-0086 on May 20, 2009 (the “Certificates”).
3. As a result of the *Pro Forma* Merger, which was completed on June 30, 2011, ZB no longer exists as a separate corporate entity and Zayo has assumed ZB’s operations. ZB, therefore, no longer requires the Certificates.
4. ZB does not have any customers, operations, or revenue from telecommunications services in the State of Illinois. As a result, there is no need to provide a notice of discontinuance of service.

¹ As described in a notification letter filed on March 8, 2011, ZB was merged with and into Zayo, with Zayo surviving the merger (the “*Pro Forma* Merger”). As a result of the *Pro Forma* Merger, which occurred on June 30, 2011, ZB no longer exists as a separate corporate entity and Zayo has assumed ZB’s operations.

5. ZB does not have any outstanding obligations, including deposits, to any Illinois customers.

7 Because ZB does not serve any customers or have any active telecommunications operations in Illinois, ZB respectfully submits that the withdrawal of its Certificates is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.

WHEREFORE, Zayo Group, LLC, as the successor in interest to Zayo Bandwidth, LLC, respectfully requests that the Commission grant this Petition and issue an Order withdrawing Zayo Bandwidth, LLC's Certificates, and grant all such other relief as necessary and appropriate to effectuate the relief sought herein.




