On August 4, 2011, the Citizens Utility Board, the City of Chicago and The People of the State of Illinois, collectively referred to as Governmental and Consumer Intervenors (“GCI”) filed their Initial Brief with the Illinois Commerce Commission. Errors have been identified in the Initial Brief. Therefore, GCI now submit the following errata to their Initial Brief:

Government and Consumer Intervenors’ Initial Brief


1. Generally, citations have been corrected for consistent format.
2. Generally, spacing has been corrected for consistent format.
3. The Sections of the Initial Brief have been reorganized in sequential order.
4. On the cover page and page 1, “Corrected” was added to the title of the document.
5. On page 2, “Marcelin–Reme” has been changed to “Marcelin-Reme” on the 3rd line.
6. On page 26, the words “the Commission not accept” and “an application from a” were added and the word “should” was removed from the 4th-6th lines.

7. On page 28, the words “the availability of” was removed and the words “available to new applicants is” were added to the 4th line.
8. On page 29, the word “otherwise” was added to the 5th line and the word “the” was changed to “their” on the 14th line.
9. On page 32, “recommends” has been changed to “recommend” on the 20th line.
10. On page 33, the word “be” was added to the 3rd line.
11. On page 47, “recommends” has been changed to “recommend” on the 5th line.
12. On page 50, the word “fluctuate” was changed to “fluctuations” on the 5th line.
13. On page 54, a citation was added at the 20th line and the words “CITE Staff direct” were deleted.
14. On page 55, the word “actually” was added and the words “every other month” were deleted from the 1st-2nd lines.
15. On page 58, “recommends” has been changed to “recommend” in footnotes 3 and 4.
16. On page 59, the word “the” was added to the 19th line.
17. On page 63, “staff’s” was changed to “Staff’s” on the 13th line.
18. On page 66, the word “premise” was changed to “premises” on line 17th line.
19. On page 67, the word “premise” was changed to “premises” on line 1st line and the word “which” was changed to “that” on the 20th line.
20. On page 68, the word “premise” was changed to “premises” on line 17th line; the word “contact” was changed to the word “contract” on the 18th line; and, the word “than” was changed to “that” on the 19th line.
21. On page 70, the words “to gain access” were added to the 14th line, and the words “Paying customer” were changed to “Paying-customer” on the 20th line.

22. On page 71, the word “of” was added to the 5th line and the word “seasonal” was added to the 21st line.
23. On page 72, a comma was deleted from the 14th line.
24. On page 78, “profession” has been changed to “professional” on the 19th line.
25. On page 80, “agrees” has been changed to “agree” on the 12th line.
