Applicant, GDF Suez Retail Energy Solutions, LLC ("Applicant") respectfully requests that the Illinois Commerce Commission ("Commission") grant this **Motion for Extension of Time to File Response to Administrative Law Judge's Ruling** and in support of its motion states the following:


Applicant's Certificate of Service Authority to be an Alternative Retail Electric Supplier ("ARES Application") was filed at the Commission in the above-referenced Docket on July 19, 2011. In connection with the ARES Application, the Commission Administrative Law Judge filed a Notice of Administrative Law Judge's Ruling on August 16, 2011 requesting responses to inquiries regarding the technical requirements and managerial requirements set forth in Applicant's ARES Application. The Notice of Administrative Law Judge's Ruling required that Applicant respond on or before August 22, 2011.

In reviewing the Ruling by the Administrative Law Judge, Applicant determined that it would require additional time to prepare and gather the data requested in the ALJ Ruling in order to file a comprehensive and complete response, including the requested shared services agreements and a listing of the individuals' background and experiences within Applicant's parent company and affiliate company to meet the minimum technical and managerial standards set forth in IL Administrative Code, Title 83: Public Utilities, Part 451, Section 451.330 and 451.340. Applicant believes that the submission of executed contracts and the gathering of data from several individuals will reasonably take an additional two (2) weeks to finalize and file final responses to the Commission.

**Applicant respectfully requests that the Commission grant its Motion for Extension of Time to File Response to Administrative Law Judge's Ruling and extend the time allowed for filing of a response to the Administrative Law Judge's Ruling to on or before August 31, 2011.**


