**NORTH SHORE GAS COMPANY AND
THE PEOPLES GAS LIGHT AND COKE COMPANY’S MOTION
TO CORRECT THE TRANSCRIPT OF THE AUGUST 30, 2011 HEARING**

North Shore Gas Company and The Peoples Gas Light and Coke Company (the “Utilities”), pursuant to Section 200.580 of the Rules and Practice of the Illinois Commerce Commission (the “Commission”) and other applicable law, respectfully moves the Administrative Law Judges to direct that the following corrections be made to the transcripts of hearings that have been held in this matter. The Utilities bring this Motion with respect to the hearing held on August 30, 2011.

In support of this Motion, ComEd states as follows:

1. Evidentiary hearings were held in this matter on August 29 through September 2, 2011 and September 6, 2011.

2. Section 200.580(b) of the Commission's Rules of Practice states that "[s]uggested corrections to the transcript of record must be filed within 35 days from the day on which the hearing is held" The rule also states that "[i]f no objection is made to the suggested corrections, the Hearing Examiner may, in his or her discretion, direct the corrections to be made

and the manner of making them." 83 Ill. Admin. Code § 200.580(d). The purpose of this determination is to "ensure the accuracy of the record." *Id.*

3. In accordance with Section 200.580, the Utilities make suggestions for corrections to the transcript for the hearing conducted on August 30, 2011, as stated on the attachment. The majority of these corrections are editorial or typographical, although several ensure the substantive accuracy of the record.

4. In accordance with 83 Ill. Admin. Code 200.580(b), a copy of this motion has been served on Sullivan Reporting Company, the official reporter for this proceeding.
