
- 1) Commonwealth Edison Company invoiced us for non-standard equipment rental for 18 months or since we bought the building in 2009 for a total through 6-27-2011 of \$4,172.28 plus \$235.83 per month moving forward. This is for rental equipment we did not know about, did not want, did not use during the period nor ordered.
- 2) Had Commonwealth Edison Company invoiced us promptly after opening our account, after the purchase of the building, at the rate of \$235.83 per month we would have taken action to have the equipment removed.
- 3) Commonwealth Edison Company has quoted a fee of \$4,136.65 to remove their rental equipment that we don't want even though we never ordered it and have never used it.
- 4) As a side note, after the removal of their non-standard equipment rental we will need to re-wire our building, that cost is estimated at \$5,000.00

Please clearly state what you want the Commission to do in this case:

We ask that the Commission eliminate the back rent of \$4,172.28 and the equipment removal fee of \$4,136.65.




