**Ruling served:**

Notice is hereby given by the Administrative Law Judge that Commerce Consulting Corporation d/b/a Energent ("Applicant") failed to indicate in its application whether it is licensed as an agent, broker, or consultant in any other jurisdictions, similar to the licensure required under Section 16-115C of the Illinois Public Utilities Act. Applicant is directed to provide the missing information.

Notice is also given that Applicant did not disclose whether it has had any complaints filed against it for its provision of any services in the electric or gas industry in this or any other jurisdiction. Applicant is directed to provide the missing information. If any complaints have been received, Applicant is directed to include in its response the nature of the complaint, the jurisdiction, and the ultimate resolution.


