COMPLAINT

Plaintiff hereby dispute Com-Ed Billings of Service from 8/17/2011 to 9/19/2011, 7/19/2011 to 8/17/2011, 6/17/2011 to 7/19/2011, 5/18/2011 to 6/17/2011, 4/19/2011 to 5/18/2011, 3/21/2011 to 4/19/2011, 2/18/2011 to 3/21/2011, 1/20/2011 to 2/18/2011, 12/17/2010 to 1/20/2011, 11/16/2010 to 12/17/2010, 10/18/2010 to 11/16/2010, 9/16/2010 to 10/18/2010, 2/18/2010 to 3/22/2011, 1/20/2010 to 2/18/2010, 12/17/2009 to 1/20/2010, 12/17/2010 to 1/20/2010, 11/16/2009 to 12/17/2009, 10/16/2009 to 11/16/2009, 9/17/2009 to 10/16/2009, 8/19/2009 to 9/17/2009, and not limited to the foregoing; and Com-Ed demand of deposit of money, on the following grounds:

1. Com-Ed knowingly and intentionally committed falsification of records and fraudulent billings and failed to read the Electric Meter to avoid presentation of the factual actual Electric KiloWatt (kWh) usage.

2. Com-Ed knowingly and intentionally with intent to commit extortion demanded deposit of money base on the fraudulent billings of service.

3. Further, the electric service meter of the property is accessible to Com-Ed and by the same token Com-Ed has full access to the meter. From 9/16/2010 to this date, Com-Ed deliberately did not read the Electric Meter so Com-Ed can engage in fraudulent billing activity and rip-off the Consumer-Plaintiff. No other reason is there for Com-Ed not reading its electric service meter. Com-Ed acted in bad faith.

4. Com-Ed statements and graph therein in its billings - "Your Usage Profile 13 Month Usage (Total kWh)"; "Electric Usage"; "Average Daily" et cetra are phoney and false and fraudulent estimate data and lacks truth and honest factual actual data.

5. In-Law and In-fact, it is the responsibility of Com-Ed to read its electric service meter and present actual electric kWh usage by the consumer. Com-Ed has failed to do its job and knowingly and intentionally continue to engage in unscrupulous and crooked business conduct - presenting phoney and false and dectieful fraudulent electric kWh usage estimates and fraudulent billings. Com-Ed made a choice and has itself to blame for its crooked actions and suffer the consequence.

6. Also, Com-Ed knowingly and intentionally continue to bill the electric service of someone called "DANA HUGHES" to Plaintiff Electric Meter No 140148897, and Plaintiff informed Com-Ed and Com-Ed failed to come to Plaintiff premises to check the Electric Lines to see if this so called Dana Hughes or any one else electric service is Hooked-Up to that of Plaintiff and make corrections and Install New Electric Meter with Zero Settings for a fresh start to assure the integrity of Com-Ed Service.

RELIEF

WHEREFORE, Plaintiff pray Illinois Commerce Commission for Order as Follows:

a). On June 25. 2009 Plaintiff purchased Boarded-Up Bank Foreclosed Property. Thereafter, Com-Ed proceeded to provide electric service and from thereon read the Electric Meter of the property each Month. The property is in bad shape and not habitable and a Home Security Electric Alarm is the only item working in the property from 6/30/2009 to 5/19/2010 and Com-Ed bill for electric service averaged \$12 (twelve dollars) a Month and paid by Plaintiff. This payment amount be Affirmed/Upheld for the foregoing period (6/30/2009 to 5/19/2010).

b). Com-Ed read the Electric Meter each Month for the 4 (four) Months 5/19/2010 to 9/18/2010 Hot Summer Months Electric Usage Peak Period. The Electric Bill averaged \$98 (ninety eight dollars) each Month and payed by Plaintiff. The property is not fully functional and just a big empty space since the date of purchase to this date and no furnishing, no TVs and Videos and Computers and land line Telephones, etc. Heat and Cooking is Gas, and the property is a green property and has big big glass windows all over it that lets in daylight and sunlight into all of the property and use of electric light in the property is cut to a minimum. This \$98 a Month Electric Bill is fair and the right amount due Com-Ed each Month from 9/18/2010 to this date and be Affirmed/Upheld by the Commission.

c). Com-Ed interest charges and deposit demand be declared null and void. For cause, the interest charges and deposit are fraudulent and resulted from Com-Ed falsification and fraudulent Month to Month Electric kWh Usage Estimates and fraudulent Billings.

d). Com-Ed check Plaintiff's Electric Lines and assure no one else electric service is hooked-up to Plaintiff's Service and Meter and Com-Ed install New Electric Meter with Zero Setting for a fresh start and integrity of service.




