**VERIFIED PETITION TO INTERVENE OF
THE VILLAGE OF PLEASANT PRAIRIE, WISCONSIN AND NOTICE OF
APPEARANCE**

The Village of Pleasant Prairie, Wisconsin ("Village"), by its undersigned attorneys, pursuant to 83 Ill. Adm. Code § 200.200, does hereby respectfully petition the Illinois Commerce Commission ("Commission") for leave to intervene and be made a party in the above captioned proceeding. In support of this Petition, the Village states as follows:

1. This docket was initiated by the American Transmission Company LLC ("ATC") filing its Application for Certificate of Public Convenience and Necessity on September 29, 2011.

2. In this docket, American Transmission Company LLC (ATC) seeks permission to construct, operate, and maintain a new 345,000 volt electric transmission line in the states of Illinois and Wisconsin. The proposed line will begin at ATC's

existing substation in Pleasant Prairie, Wisconsin, and will end at the substation at the Zion Energy Center in Zion, Illinois

3. The Village of Pleasant Prairie is an incorporated village located in Kenosha County, Wisconsin.

4. The proposed construction and operation includes the installation of lines in the Village on private and public property and depending on the chosen route could impact land use development and future roadway improvements in the Village.

5. Accordingly, the Village and its residents will be directly impacted by the Commission's decision to approve or deny the requested transmission line construction, and the route chosen if approved and therefore it requests intervention under 83 Ill. Adm. Code § 200.200.






