Dear Ms. Rolando:

Pursuant to Section 16-115(b) of the Public Utilities Act ("Act") and Section 451.30(a), Public Power, LLC ("Public Power") has published notice of its application for a certificate of service authority as an alternative retail electric supplier in the Official State Newspaper, The Breeze Courier. An original and two copies of the proof of publication is enclosed.

Section 451.30(a) of the Act requires that the notice must be published within ten (10) days following the filing of the application for certification. Notice of Public Power's application, dated January 13, 2012, was published on January 18, 2012, fulfilling this requirement.
