**Subject:** Docket No. 11-0721 - ComEd's Notice re: HB 3036

Dear Judges Sainsot and Kimbrel, Counsel, and Others –

At the time ComEd prepared the submissions that led to this Docket, no one was certain if or, if so, when the “Trailer Bill” (HB 3036) referred to therein would become law. ComEd, therefore, provided a number of documents in the alternative, as discussed in the direct testimony of Dr. Hemphill (ComEd Ex. 1.0).

On December 30, 2011, the Trailer Bill was signed by Governor Quinn and became law as PA 97-0646. ComEd will, therefore, be offering into evidence those alternative documents applicable to the law as modified by the Trailer Bill. In general, those documents are the exhibits that have the suffix “TB,” reflecting their applicability to the Trailer Bill.
