RESPONDENT'S MOTION TO DISMISS

Now comes the Respondent, Commonwealth Edison Company ("Respondent" or "ComEd"), by and through its attorney, Mark L. Goldstein, and files this Motion to Dismiss With Prejudice the Formal Complaint filed by the Complainant, Kinyara Shepherd ("Ms. Shepherd"), with the Illinois Commerce Commission ("Commission") on August 31, 2011, and in support thereof, states, as follows:

1. Ms. Shepherd's Complaint alleges that ComEd improperly transferred her mother's electric bill balance to her residential electric account at 7134 South Cornell, Chicago, Illinois ("Property").
2. Ms. Shepherd's requested relief is that these electric charges be removed from her account.
3. On October 6, 2011, ComEd adjusted Ms. Shepherd's electric Property account as indicated by her ComEd Electric Account History attached as Exhibit A.
4. With the removal of the disputed charges in question by ComEd, all matters in dispute in this complaint have been resolved, the complaint is moot and should be dismissed with prejudice.

WHEREFORE, the Respondent, Commonwealth Edison Company, respectfully requests that the Complaint filed by Kinyara Shepherd on August 31, 2011 be dismissed with prejudice.


