COMES NOW Bond-Madison Water Company, an Illinois not-for-profit corporation, by and through its attorneys, Jeffrey A. Mollet and Silver Lake Group, Ltd., and for its Petition for Leave to Intervene, states as follows:

1. Petitioner is an Illinois not-for-profit corporation operating a water system for the sole benefit of its members/owners in Bond County and Madison County, Illinois.
2. Petitioner is the user of a substantial amount of water within the Illinois-American Water Company ("IAWC") service territory.
3. Petitioner in fact purchases all of its water from IAWC pursuant to contract.
4. As such, Petitioner and Petitioner's members will be substantially affected by the decision of the Illinois Commerce Commission in this rate case matter.
5. Petitioner agrees to accept service by electronic means as provided for in Section 200.1050 of the Commission's Rules of Practice.
6. Petitioner intends to be active in this proceeding.

WHEREFORE, Bond-Madison Water Company prays that it be granted leave to intervene in and become a party to this matter for the purpose of producing evidence and cross-examining witnesses, together with the right to file such briefs and evidence as may be appropriate and allowable, and to participate in oral argument before the Illinois Commerce Commission should oral argument be granted, required or requested.


