RESPONSE TO NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING

**General Requirements**

- 1. Subsection 451.20(c)(1) of 83 Ill. Adm. Code 451 requires Applicant to provide its name and street address.

Applicant's actual name is HIKO Energy, LLC ("HIKO"). HIKO's current address is 12 College Road, Monsey, NY 10952.

- 2. Paragraph 3 of the application form directs Applicant to provide the email address of each contact person.

3. Subsection 451.30(c)(3) of 83 III. Adm. Code 451 requires that proof of notification of intent to serve in any utility's service area has been previously provided to the utility. Proof of notification the utility is attached as "Attachment A".
4. Paragraph 20 of the application form directs Applicant to disclose whether it has had any complaints filed against it for provision of any services in the gas or electric industry in this or any jurisdiction.

HIKO has only received complaints from customers through the New York Department of Public Service. Attached is a detailed report of every complaint we have received and the resolutions as "Attachment B".

5. Applicant must submit financial information pursuant to Section 451.320.

To meet the financial requirements stated in the Administrative Code Section 451.320 under subpart D, attached is a certification that HIKO Energy, LLC ("HIKO") is a member of PJM and purchases 100% of its physical electric energy from PJM and NYISO for delivery to service territories as "Attachment C: 1". HIKO will purchase 100% of its physical electric energy from PJM for delivery to the Common Wealth Edison service territory. Attached is proof of membership with PJM as "Attachment C: 2".

6. Subsection 451.330(b) of 83 III. Adm. Code 451 explains that Applicant must meet certain Technical Requirements.

Demonstration of HIKO's technical capabilities is attached as "Attachment D".

7. Section 451.340 of 83 III. Adm. Code explains that an applicant shall be deemed to possess sufficient managerial capabilities if it has three or more individuals in management positions that possess four or more years of occupational experience in each of the three identified managerial area.






