PLEASE TAKE NOTICE that, pursuant to Section 10-201 of the Public Utilities Act (“PUA”), 220 ILCS 5/10-201, and Section 200.890 of the Illinois Commerce Commission’s (“Commission”) Rules of Practice, 83 Ill. Adm. Code 200.890, the Citizens Utility Board (“CUB”) is appealing to the Appellate Court of Illinois, Second District, from the Orders of the Commission in Commission Docket Numbers 11-0280 and 11-0281 (consolidated), entered on January 10, 2012 (Commission Final Order) and served on January 12, 2012; and February 23,

2012 (Commission Order denying CUB's Application for Rehearing¹) and served on February 24, 2012.


