**VERIFIED PETITION TO INTERVENE OF THE HEFFERNAN FAMILY**

**THE HEFFERNAN FAMILY (Heffernan's)**, hereby petitions the Illinois Commerce Commission ("Commission") to intervene and be made a party of record in the above captioned docket. The Heffernan's state the following grounds in support of their petition:

1. The Heffernan's are property owners and farmers that will be directly and adversely affected by the placement of new electrical transmission lines as proposed by Ameren.
2. Ameren presents two options for its Alternate Route for the 138,000-volt electric line, one roadside, running along S. Rising Road and the other bisecting property while running parallel to S. Rising Road. This latter route would cut directly through the center of the land owned by the Heffernan's and the concern is the negative impact that this would have on both property value and future development opportunities.
3. The Heffernan family acknowledges the importance of this project and is grateful for the public service that Ameren provides; however the Heffernan family prays the court find the Preferred Route to be the more suitable option.
4. The Heffernan family agrees to accept service by electronic means as provided under Section 200.1050 of the Commission Rules of Practice.
