PETITION TO INTERVENE

Pursuant to 83 Ill. Admin. Code 200.200 the Environmental Law & Policy Center (“ELPC”), through its counsel, petitions the Illinois Commerce Commission for leave to intervene in the above-captioned matter. In support of its petition, ELPC states the following:

1. ELPC is a not-for-profit organization that works to promote environmentally-sound energy policies in Illinois.
2. On March 21, 2012, the Commission issued an order initiating this proceeding to establish certification requirements that shall be applicable to vendors that install electric vehicle charging stations, pursuant to Subsection 16-128A(d) of Public Act 97-0616.
3. ELPC has members in Illinois who have a deep interest in electric vehicle policies and will be directly and materially affected by the Commission’s rules regarding certification requirements for electric vehicle charging stations.
4. ELPC agrees to accept service by electronic means as provided for in Section 200.1050 of the Commission’s Rules of Practice. (83 Ill. Adm. Code 200.1050).

WHEREFORE, for the above stated reasons, ELPC requests that leave to intervene be granted by the Commission and it be made a party to this proceeding, and requests that all

orders, notices, correspondence, pleadings, testimony and other documents be served upon the undersigned.
