IDT is a retail supplier of natural gas and electricity

IDT seeks to be authorized to offer service in the Commonwealth Edison service area.

*IDT Energy, Inc. intends to offer electric supply service under **Subpart D**, to residential, large and small commercial customers. Our focus is on these smaller volume customers.*

14. IDT **certifies** that it will provide for review by Staff on a confidential and proprietary basis data related to contracts for the purchase and sale of electric power and energy; [451.20(b)]
15. IDT **shall certify** it will procure renewable energy resources as required by Section 16-115D and subsection (d) of Section 16-115 of the Act, or shall certify that Section 16-115D and subsection (d) of Section 16-115 of the Act do not apply to it pursuant to subsection (h) of Section 16-115D of the Act. [451.20(f)].
16. IDT **shall certify** that it will source electricity from clean coal facilities, as required by Section 16-115(d)(5) of the Act. [451.20(g)]
17. IDT **agrees** to adopt and follow rules and procedures ensuring that authorizations received from customers, customer billing records, and requests for delivery service transmitted to utilities are retained for a period of not less than two calendar years after the calendar year in which they were created. 18. IDT **agrees** to adopt and follow rules and procedures to preserve the confidentiality of its customer's data. [451.40(b)]

IDT is a licensed supplier in New York, Pennsylvania, New Jersey and Maryland with customers in 22 different utilities as of this filing. IDT operates a customer service center that receives and processes consumer inquiries and customer complaints. All customer complaints/issues are responded to in a timely and efficient manner.

IDT has not been subject to any formal complaints. Each utility service area within each State jurisdiction requires effective customer service and complaint response. IDT's Quality Control Department coupled with our Customer Service Department meets or exceeds all requirements. IDT will meet or exceed the State of Illinois requirements as well.

LICENSE OR PERMIT BOND [451.50]

21. Applicant is required to execute and maintain a copy of the license or permit bond in the name of the People of the State of Illinois issued by a qualifying surety or insurance company authorized to transact business in the State of Illinois. 


