


IN REGARDS TO THE FINDINGS IN CASE 11-0601

THE COMMISSION FINDINGS BASED ON MR. DOLECHECK TESTIMONY IS IN ERROR.

1) MR. DOLECHECK STATED HE WAS UNABLE TO SAY WHETHER MR. HOSEK HAD A HIGHER LEVEL OF OUTAGES COMPARED TO OTHER CUSTOMERS. COM ED EXHIB.3 SHOWS TWO HOMES ON MY STREET WITH 4 OUTAGES AND TWO HOMES HAD 1 OUTAGE ALL ON THE SAME STREET. THEIR EXHIBIT 3 IS BASED ON INFO I HAD REQUESTED FROM COM ED ABOUT OUTAGES IN MY AREA. HOW CAN THAT BE 75% LESS OUTAGE ON THE STREET.

ALSO IF MR DOLECHECK DID ANY SERIOUS RESEARCH OF THE OUTAGES WHY DID HE NOT FIND COM ED HAD CONTRACTORS REPLACING UNDERGROUND CABLE TO HOMES WEST OF MY HOME. ALSO ON THE EXHIBIT THERE ARE TWO ADDRESSES WITH 4 OUTAGES, 1 ON KICKAPOO AND 1 ON POAWATOMI. BOTH THESE HAD CONTRACTORS REPLACING UNDERGROUND CABLE TO THE HOMES. ALL THIS WORK WAS DONE BETWEEN THE END OF JUNE 2012 AND MIDDLE OF JULY 2012. WHY WAS THIS WORK DONE IF NO PROBLEMS EXIST IN MY AREA. IF YOU LOOK AT EXHIBIT 3 PAGE 2 YOU WILL SEE 1 OUTAGE PER HOME FOR THE SAME TIME PERIOD AS PAGE 1. ALSO NOTE THAT FEEDER CABLE HAS BEEN REPLACED 3 TIMES SINCE 2004 SEE EXHIBIT 1. WHY???? 20 OUTAGES 8 EQUIPMENT FAILURES. IS IT POOR MAINTENANCE OR FAULTY EQUIPMENT??? 6 TREE/VEGETATION FAILURES POOR PREVENTIVE MAINTENANCE??? 4 WEATHER RELATED??? FINALLY ON 8/14/2012 WE HAD ANOTHER OUTAGE DURING THE NIGHT. NO STORM NO WIND NO LIGHTENING BUT A CABLE FAILURE PER COM ED. THEREFORE I AM REQUESTING THAT THE COMPLAINT NOT BE DENIED AND THE COMMISSION PURSUE THE OUTAGE ISSUE REQUIRING COM ED TO DO A COMPARISON ON OUTAGE IN MY AREA. COM ED HAS THE RECORDS AND ARE RESPONSIBLE TO PROVIDE THE INFO WHEN THERE IS A QUESTION TO SERVICE QUALITY. THE PROOF IS IN THE RECORDS AND THE COMMISSION HAS THE AUTHORITY TO ORDER A COMPARISON OF SERVICE IN HOMER GLEN BY COM ED.
