**RESPONSE TO NOTICE OF ADMINISTRATIVE LAW JUDGE'S RULING**

Dear Administrative Law Judge Albers,

The following is our response to the inquiry made on October 23, 2012.

- 1) Applicant's October 17, 2012 response to the October 1, 2012 ALJ ruling indicates that the discrepancy regarding the use of Elena Gallo's name as its attorney in Docket No. 12-0427 "was a mere oversight in timing between filing the application and contacting Ms. Gallo." How can the Commission be assured that similar "mere oversight[s] in timing" will not occur in Applicant's dealings with customers?**

The miscommunication and/or oversight that led to the discrepancy referenced in our October 17, 2012 response is not indicative of our primary focus on ensuring customer satisfaction, on-time quality enrollments, and complete transparency. To do so, we will build a technically sounds, continuously educated broker-agent base, that will not only represent various alternative retail energy suppliers, but more importantly be true energy advocates for the customer.

Mark Nakayama is well versed in the supplier contract language for energy supply agreements. We have taken steps to ensure the agents understand and are trained on explaining the terms and conditions of energy service agreements, as well as the timeline for a proper enrollment.

- 2) Applicant's October 17, 2012 response to the October 1, 2012 ALJ ruling indicates that Applicant has changed its name to "Navigate Power, LLC." As such, Applicant must submit a copy of the file stamped paperwork from the Secretary of State's office reflecting the Applicant's new name.**

**Additionally a new license or permit bond, or a copy of a rider to its existing license or permit bond, reflecting Applicant's new name must be submitted.**
