include the changes in rates as compared with the rates now in effect, the approximate number of customers affected, and the estimated increase in revenue resulting from the change in rates.

In accordance with Title 83 of the Illinois Administrative Code, Part 255, Lake Wildwood will cause notice of the filing of the proposed rates to be published in a newspaper of general circulation in the territory affected. A notice of the filing will be posted in its business offices, and the Company will cause notice to be sent to its customers with the first billing after filing. Lake Wildwood also intends to make a special mailing providing notification to all customers of the new charges.


