AMEND PETITION TO INTERVENE**


Petitioner, Clark County Preservation Committee, (the "Clark County") by counsel and pursuant to 83 Illinois Administrative Code Sections 200.190 and 200.140, hereby motions the Illinois Commerce Commission (the "Commission") for leave to amend its Verified Petition to Intervene. In support of its Motion, Clark County states as follows:

1. On November 26, 2012, Clark County, by representative Johnie T. Snedeker, filed its Verified Petition for Leave to Intervene in the above-captioned proceeding.
2. On November 29, 2012, Ameren Transmission Company of Illinois ("ATXI") submitted a Response in Opposition to Clark County's Verified Petition for Leave.
3. Upon engaging counsel and the discovery of facts now very much relevant to Clark County's Verified Petition for Leave to Intervene filed November 26, 2012, Clark County wishes to amend its Petition.
4. The Commission has yet to rule on Clark County's Verified Petition to Intervene and permitting Clark County to amend its Petition would neither prejudice ATXI, nor unduly burden the Commission.

WHEREFORE, Clark County respectfully requests that the Commission grant Clark County leave to amend its Verified Petition filed on November 26, 2012.


