PETITION TO INTERVENE

COMES NOW Missouri Gravel Company, now known as Central Stone Company, a Missouri corporation duly licensed to do business in the State of Illinois, with its principal office located at 1701 - 5th Avenue, Moline, Illinois, by and through its Attorneys, Alvine & Alvine, and hereby presents its **PETITION TO INTERVENE** in this proceeding, states as follows, to-wit:

1. Petition was filed by Ameren Transmission Company of Illinois, Petitioner, in the above-captioned cause on November 7, 2012.

2. Petitioner (Ameren) seeks approval from the Illinois Commerce Commission ("Commission") for a Certificate of Public Convenience and Necessity pursuant to Section 8-406.1 of the Illinois Public Utilities Act, and an Order pursuant to Section 8-503 of the Public Utilities Act,

to Construct, Operate and Maintain a New High Voltage Electric Service Line and Related Facilities in many counties in the State of Illinois, and specifically, in the following two (2) counties where Central Stone Company is directly affected: Adams County and Pike County, Illinois.

3. Petitioner (Ameren) gave notice of the above-captioned proceedings to Missouri Gravel Company and Missouri Gravel Company was, in fact, merged into Central Stone Company on August 13, 1987, all as shown by the records in the office of the Illinois Secretary of State.

4. Intervenor, Central Stone Company, operates a limestone quarry in Sections 31 and 32 of Melrose Township, and Sections 5 and 6 in Fall Creek Township near the Village of Marble Head in Adams County, Illinois.

5. Intervenor, Central Stone Company, (formerly known as Missouri Gravel Company) operates a limestone quarry in Sections 8 and 17 in Chambersburg Township, Pike County, Illinois.

6. That Central Stone Company, by virtue of being the record title owner of the two (2) pieces of real estate described in the two (2) preceding paragraphs, shall be substantially affected by any decision of the Illinois Commerce Commission in these proceedings.

7. Accordingly, Central Stone Company, a Missouri corporation, duly licensed to do business in the State of Illinois, and successor in interest to Missouri Gravel Company, seeks to **INTERVENE** and be treated as an active party in these proceedings, in order to formally protect its interests in this matter.

8. Central Stone Company agrees to accept service by electronic means as provided for in






